<b>Objectives of the Program</b>	Objectives of the Program are to build understanding about personal data protection law and readiness of human resources management, for example, procedures for supporting exercises of rights of employees, who are owners of the data, preparation of legal documents, drafting of policies on personal data protection for employees, amendment to employment contract and work rules as to be consistent with the law, and transmission or transfer of personal data of employees to competent agencies.
<b>Lecture Topics</b>	<p><b>Principles, scope and impact of Personal Data Protection Act, B.E. 2562 (2019), on Human Resources Management:</b></p> <ul style="list-style-type: none"> <li>■ Definition and scope of personal data, personal data controller, personal data processor;</li> <li>■ Approaches to interpretation;</li> <li>■ Legal grounds for collecting and using data of employees (lawful basis for processing);</li> <li>■ Consent and other grounds, on which consent from employees is not necessary for processing data;</li> <li>■ Management of relations between employers, as the employees' data controller, and third-party data processors;</li> <li>■ Risk of criminal punishments, administrative actions and civil damages;</li> <li>■ Readiness of human resources management work and administration work for compliance with the law;</li> </ul> <p><b>Readiness for compliance with the procedures and conditions, and preparation of legal documents:</b></p> <ul style="list-style-type: none"> <li>■ Procedures for supporting exercises of rights of employees, who are owners of the data, for example, deletion, modification, transfer, removal of the data, and objection to processing;</li> </ul>
